**Report of the Trustees  
for the Year Ended 31 March 2021**

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

**OBJECTIVES AND ACTIVITIES**

**Objectives and aims**

- to advance heritage by preserving and conserving Govanhill Baths as a building of historic and architectural interest.
- to advance mental and physical health through provision of a wellbeing centre within the building.
- to provide recreational facilities for a variety of activities, including swimming, fitness and games.
- to advance community development through initiatives that contribute to the wider social, cultural, health and built regeneration of Govanhill.

**Incorporation**

The charitable company was incorporated on 16 August 2017.

**ACHIEVEMENT AND PERFORMANCE**

**Charitable activities**

Govanhill Baths Community Benefit Society (CBS) was established in 2017 and will take on the work of Govanhill Baths Community Trust to continue the legacy of its campaigning as it takes on the role of managing Govanhill Baths when reopened as a Health and Wellbeing Centre.

Throughout the reporting period, the CBS Board of Directors met on a regular basis.

The Board have continued to update members of the Society on the progression of the refurbishment of the Govanhill Baths building.

In the year 31 March 2019 to 01 April 2020 the Board invested £170,000.00 of capital in two one-year fixed bonds. During the current reporting period both bonds matured. The interested accrued with United Trust Bank was withdrawn and the balance transferred to a new one-year fixed bond. The funds held with Hampshire Trust Bank, including interest accrued, were transferred into an Easy Access Account with the bank.

The Society's Annual General Meeting was held on 29 September 2020 with members and the Board attending remotely via Zoom. Following the Society's governing Rules, Board members Frances Diver and Fatima Uygun stood down and were re-elected without opposition.

Discussions continued with the society's board and boards of partner organisations: Govanhill Baths Community Trust and Govanhill Baths Building Preservation Trust. These discussions were supported by Development Trust Association of Scotland about the future role of the Society in the operation of Govanhill Baths building.

**FUTURE PLANS**

I report on the accounts for the year ended 31 March 2021 set out on pages four to eleven.

**Respective responsibilities of trustees and examiner**

**1. ACCOUNTING POLICIES**

**Basis of preparing the financial statements**

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

**Income**

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

**Expenditure**

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

**Taxation**

The charity is exempt from corporation tax on its charitable activities.

**Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
